# Effective public policy on carbon pricing in support of climate objectives: views from North America and Europe

## June 15th, 2022

Join us for a high-level review of key trends and lessons learned in pricing the external cost of carbon emissions — the cost borne by society and the environment due to human-induced climate change — with renowned experts, decision-makers, and elected representatives from the United States, Canada, France and the European Commission.

Recent weeks and months have illustrated the volatility of energy prices worldwide and some worrying disruptions of the traditional supply of energy, while at the same time the need to reduce global greenhouse gas emissions has become increasingly pressing. Against this background, the French Embassy (under the auspices of the French Presidency of the Council of the European Union) and the Delegation of the European Union to the United States will bring together experts in carbon policies from both sides of the Atlantic, with policy- and law-makers to assess policy options to meet the challenge of managing carbon emissions externalities.

This half-day conference will feature three sessions of panel-driven discussions, a review of the day's outcome with comments by distinguished elected officials, and a networking reception.
